#### **Visiting Music Teachers**

Visiting Music Teachers (VMTs) are self-employed with the contract for provision of lessons are made directly between parents/carer and the VMT

We are looking for musicians who will uphold Ursuline Academy Ilford's values and ethos which is underpinned by Gospel values and the Ursuline motto of 'Serviam'. Be committed to fostering an inclusive environment where music is accessible for all. VMTs are expected to deliver high quality, enjoyable lessons, inspiring and engaging pupils of all musical abilities across the Academy and Sixth Form.

The ideal candidate will have proven experience teaching their main instrument to grade 8 and, ideally, a second instrument to grade 5.

#### Instrumental Tuition Charges:

Based on 30 minutes: Individual lessons cost £216 per term (£18 per lesson).

Based on 20 minutes: Individual lessons cost £144 per term (£12 per lesson);

Shared lessons (2 students) cost £72 per term (£6 per lesson).

## **DEPARTMENT INFORMATION**



At Ursuline Academy Ilford, we are committed to the continuous elevation of the profile and standard of music-making within our whole-school community. With a keen interest in music existing among both students and parents, and a supportive staff community that champions musical endeavours, we are proud of our pupils' musical achievements. Music teaching at Ursuline Academy spans both the Secondary Academy and Sixth Form, delivered by dedicated staff who work across Key Stages.

Our young women are inspired by the witness of St Angela and the vibrant school community, whose motto 'SERVIAM' - I will serve, empowers us all to play our full part in society. Inspired by our Catholic foundation, the role of music is prevalent in school life, with students regularly participating in choral singing and ensemble music-making opportunities. Our VMTs are key to the further development of ensembles and performance opportunities within the Academy and further afield.

The department houses a suite of specialist instrumental practice rooms, recording room, department office, storage and music room. VMTs provide lessons in a range of disciplines including voice, electric guitar, bass guitar, acoustic guitar, drum kit, keyboards, piano, violin, brass and woodwind. Mass takes place in our Chapel and Main Hall, which also provides a high-quality performance space with digital live PA for larger events.

The music curriculum at UAI is broad and balanced, offering a diverse scope of musical genres and styles, whilst incorporating students' cultural and individual musical interests.



### JOB DESCRIPTION

#### Visiting Music Teachers



Ursuline Academy Ilford is seeking enthusiastic and experienced visiting music teachers to deliver one-to-one lessons in Drum Kit and Voice from July 2025. Visiting Music Teachers (VMTs) are self-employed, and the contract for provision of lessons are made directly between parents/carers and the VMT. We are looking for musicians who will uphold UAI's values and are committed to fostering an inclusive environment where music is accessible for all.

VMTs are expected to deliver high quality, enjoyable lessons, inspiring and engaging pupils of all musical abilities across the Junior and Senior School.

#### Key responsibilities:

• Liaise with the Subject Lead for Music re: agreeing weekly teaching timetable, taking into account school events as detailed in the school's termly calendar

- Where relevant, enter students for instrumental exams either privately or during a examination board special visit organised by the department
- Establish a teaching environment that is positive and supportive of learning
- Consider the needs of pupils at all times interacting in a supportive and positive way
- Establish a culture for learning with pupils of all abilities
- Establish effective teaching practices so that pupil behaviour is consistently within the expectations of this school being purposeful, safe, respectful, open, valuable, and appropriate
- Align with departmental policies and procedures in the maintenance and storage of all equipment and resources
- Liaise with parents regarding all invoicing and contractual matters, pupil progress and targets
- Sign in and out in the usual way, in the Academy, to ensure compliance
- Notify the Subject Leader for Music and SLT Line Manager about absence in keeping with the department procedure

• Safeguarding - every child's welfare is of paramount importance. Our Academy promotes an ethos where pupils feel secure, are encouraged to talk, are listened to and are safe. Children at our Academy are able to talk freely to any member of staff if they are worried or concerned about something.

• It is the responsibility of every VMT to ensure that they carry out the requirements of the school's Safeguarding Policy and, at all times, work in a way that will safeguard and promote the welfare of all of the pupils at this school. This includes the responsibility to provide a safe environment in which children can learn

- Experience of teaching the instrument to children aged between 11 and 18
- Be a positive and well-presented person, capable of inspiring confidence in pupils and parents
- Understand the skills required when teaching pupils with a range of abilities, encouraging all to develop to their maximum potential
- Have calmness, efficiency and the ability to work under pressure at certain times
- Be prepared to work hard with energy and enthusiasm
- Have an awareness of health and safety issues and be able to comply with health and safety policy
- Understand safeguarding within a school environment and be willing to undertake regular update training
